Jake Linn: Before we adjourn we need to address something. I was looking this up while we're sitting here, I believe to suspend the rules and requiring three reads. We need to have the vote of three fourths of the members, which we don't have present here.

This is under 731.17 passage of Ordinances or resolutions. Each one shall be read on three different days provided the legislative authority may dispense with this rule by a vote of three fourths of its members. We only have 4/6 or we'll have three fourth or 4.5. So we will need five members to suspend the rules. I do think that in my opinion. I could do more research on it, I think we need to have five members here to suspend the rules. So I'm not sure I'm more confident that these are properly passed. You can suspend them with more that three fourths of the members.

I could be reading it the wrong way. But that's the way I'm reading it, so I'm going to bring that up. I am not confident that each resolution shall be read on three different day by legislative authority may dispense by this rule. And we don't have three fourths. Just wanted to bring that up for the record. Emergency is separate from special.

Melanie Smith: Emergencies to file with the County. You haven't done that since 2017. I understand a permanent budget ever since 2017 was the last one. So we're going to try to actually follow it this time.

Pennie Scarpone: Why would be even be able to hold a quorum if we couldn't vote because you always have people that don't show.

Jake Linn: You could pass without four if it was like a third vote or something like that. If you are passing it as and emergency this rule requires three readings. And I'm just reading exactly out of this. Each ordinance resolution shall be read on three different days provided by legislative authority may dispense with the rule of three fourths of its members. Now there could be case law that says the four out of six is that, I didn't know we weren't going to have at least five here tonight and so I not research to see if there's any case law that would be contradictory to that.
